



# SPORTS CAR HIRE

## Terms & Conditions

We have set out the following terms and conditions for your safety and request you to comply with them while taking part in a Morgan Sports Car Hire. Please read the terms and conditions carefully.

### DRIVER REQUIREMENTS

- Minimum age: **25**
- Maximum age: **75**  
(over 75s can still participate but as a passenger)
- Drivers must hold a full and current driving licence, and have never been disqualified from driving or had their insurance declined and/or renewal refused/cancelled.
- Drivers should have no more than 3 penalty points on their licence within the last 5 years. Any endorsements on the driver's licence within the last 5 years must be disclosed to the Morgan Motor Company upon booking.

The following endorsements are required to be referred to Morgan Motor Company's insurers;

Persons will not be allowed to drive or hire the vehicle if they have any of the following offences;

- AC: Accident offence - driving without due care and attention
- BA: Disqualified Driving
- CD: Careless Driving / Driving without reasonable consideration for other road users
- DD: Reckless/Dangerous Driving
- DR: Drink or Drugs
- IN: Insurance Offence
- UT: Theft/or Unauthorised Taking
- MS – Miscellaneous offences
- XX – Totting up
- OR any disqualifications (including TT99 –totting up / Disqualification due to maximum penalty points)

If you have not already provided your driving licence details to us upon booking, please send copies **within 21 days prior to your hire date**. Should any new endorsements be included on your licence between booking and your experience date which would preclude you driving the vehicle, your hire may be cancelled.

**PLEASE NOTE:** if the holder has a new style UK photocard driving licence, we also require a DVLA check code, which can be obtained from the DVLA website within 21 days prior to your booking [www.gov.uk/view-driving-licence](http://www.gov.uk/view-driving-licence)

We would ask that *all drivers bring their full drivers licences with them on the day*, and agree to complete a standard Insurance form which includes questions relating to medical history / driving endorsements.

**CLAIMS HISTORY:** Please let us know if you have made any motor claims or been involved in any accidents in the last 3 years.

### ACCIDENTAL DAMAGE

A **£3,000 excess** will be paid by the hirer in the event of any accident or damage being caused to the vehicle. This excess can be reduced to £1,000 for the following damage waivers;

- Day hire damage waiver = £25
  - Overnight hire damage waiver = £35
  - Weekend hire damage waiver = £70
  - Week (Mon-Fri) hire damage waiver = £100
  - Week (7 days) hire damage waiver = £125
- 
- The damage waiver is to be collected either upon booking or before the vehicle is taken on the day of hire.
  - If a damage waiver is not paid, the £3,000 Security deposit is to be held on the customer's credit card whilst the vehicle is on hire.
  - If a damage waiver is collected, the amount to be held on a credit card whilst the vehicle is on hire will be reduced to £1,000.
  - If any significant damage occurs whilst the vehicle is on hire, the security deposit will be charged in full whilst we assess the damage amount and/or claim further.

### OCCUPATIONS

Persons engaged in/as/connected with any of the following occupations will need to be referred to Morgan Motor Company's insurers;

- i) Members of the armed forces other than the armed forces of Great Britain, Northern Ireland, the Isle of Man or Channel Islands
- ii) Professional sports persons
- iii) Persons connected with:
  - a. The entertainment or theatrical profession
  - b. Racing or gambling industry

## MILEAGE

There is no mileage limit, the car will leave the factory with a full tank of unleaded fuel and we ask that it be returned in the same condition.

**PLEASE NOTE:** Our insurance only permits travel within mainland United Kingdom.

## CANCELLATION

Any hire cancelled within 28 days of the hire date will be subject to a 50% cancellation fee. Any hires cancelled within 14 days of the date of hire will be subject to a 100% cancellation fee. Please note that this also applies to the re-scheduling of hires within these time frames.

**PLEASE NOTE:** Unfortunately we cannot be held responsible for the weather, and so any hires cancelled or re-scheduled due to poor weather conditions (with the exception of extreme conditions) will be subject to the above cancellation and re-scheduling terms.

## ANIMALS

We do not allow any animals in the cars.

## FOREIGN USE

Driving in Europe is not permitted. Mainland United Kingdom use only.

## LIABILITY

Any personal possessions left in the cars are the hirer's responsibility. The Morgan Motor Company is not liable for the loss or damage to any property stored or transported in or on the vehicle. You will receive a booking confirmation when you collect your car, please read this carefully along with the accompanying Terms and Conditions regarding the Lessor and Hirer obligations. If you have any questions regarding these, terms or obligations, we will explain them to you.

## COLLECTING & RETURNING THE CAR

The car **MUST** be returned at the specified time (late returns may incur a surcharge to be calculated on the day).

We thank you for your co-operation and wish you a pleasurable and safe experience.

No exceptions to this policy are permitted unless with the express permission of the Chief Executive Officer or his nominated person(s).

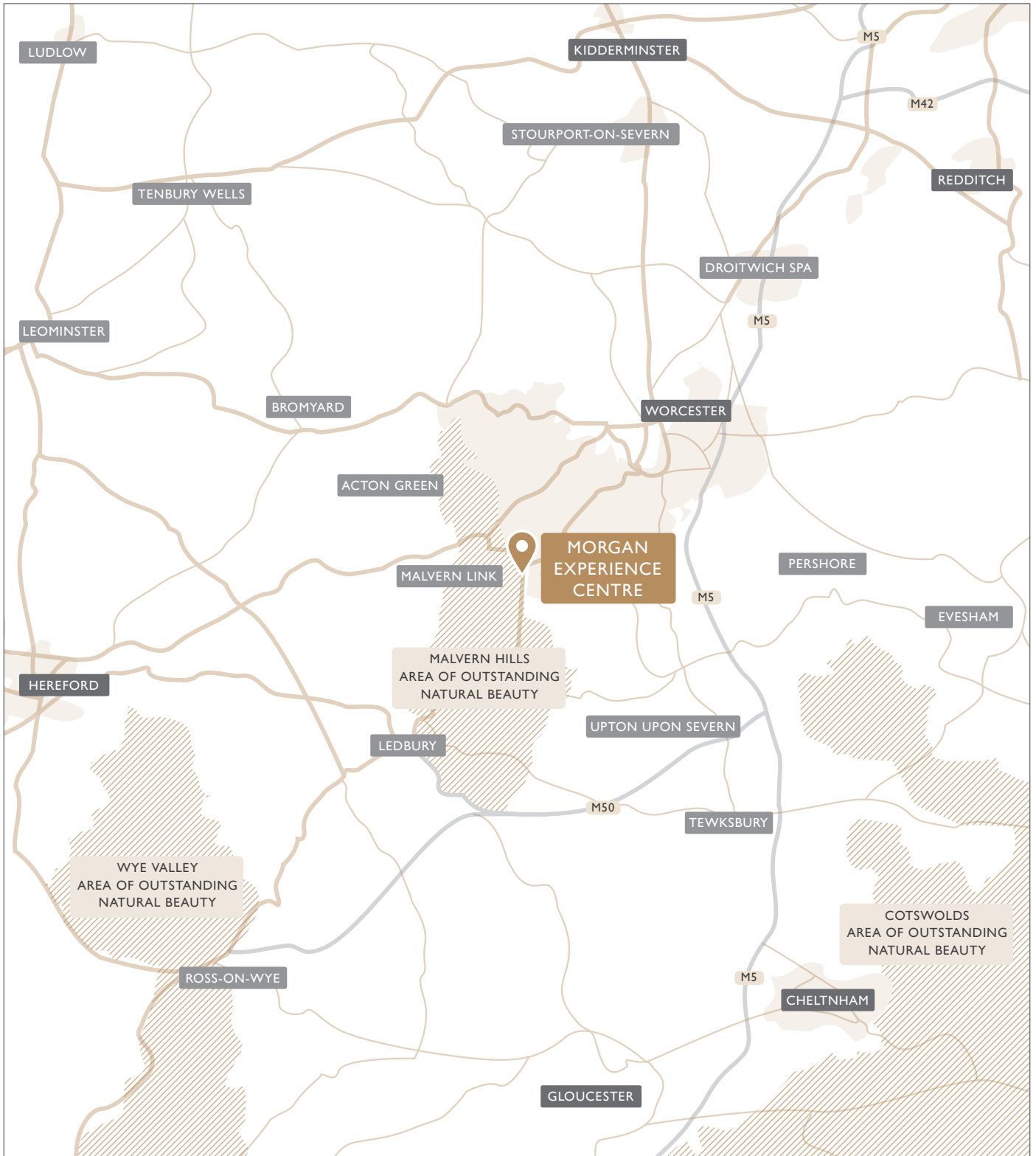
